- 3. Other Dues. The Corporation may require Members to pay additional dues, from time to time, as provided in the Corporation's Code of Regulations. Failure to pay these dues shall be cause for suspension and termination of this Agreement and all Member benefits as provided in the Corporation's Code of Regulations.
- 4. <u>Dues Nonrefundable</u>. Once paid, all Member dues, whether Annual Dues, or otherwise, are nonrefundable.
- 5. <u>Representations and Warranties of Applicant's Representative</u>. The individual executing this Agreement on behalf of Applicant represents and warrants that he or she has all requisite signing authority for and on behalf of Applicant.
- 6. <u>Organizational Documents</u>. Applicant agrees that it has been given an opportunity to review the Organizational Documents prior to signing this Agreement, and that it agrees to be bound by the provisions thereof.
- 7. <u>Choice of Law.</u> Any claim or dispute arising under or relating to this Associate Member Agreement shall be governed by the laws of the State of Ohio, without regard to principles of conflict of laws.
